Please note, when I'm teaching I will not answer phone calls, as the student in the room will be my focus. If your matter is not urgent please send me an email, or if you need to contact me about your lesson that day send me a text message instead as I will check these between lessons.

Lessons are held at Browning St Studios, 17 Browning Street, West End. There is a small waiting area at the front of the building and at the end of the hall. (Unfortunately we cannot be responsible for children in these areas, so we ask that you wait with your child until their lesson begins, and children will be instructed to wait outside my room if parents are not there to collect them at the conclusion of their lesson).

To help you make the most out of your time, it is recommended to bring a USB flash drive for copying backing tracks and recordings you may need, and a folder where you can keep any lyrics or sheet music we use during your lesson.

Lesson blocks are booked according to school terms (10-12 week blocks), and students have the option (and are encouraged!) to attend during school holidays. You will be invoiced at the beginning of each 10-12 week block.

A 5% discount applies if payment is made up front for a 10-12 week block, when payment is made within the first two weeks of a 'term'.

Terms and Conditions

The following are the Terms & Conditions of commencing lessons, including my cancellation policy. After the initial/trial lesson, you will be bound by these conditions in order to hold your regular weekly time:

When 24 hours notice is given, students are entitled to cancel 2 lessons per term.

For students who have paid up front, a reschedule will be organised at a mutually convenient time, or this fee will be credited to your account for the following term. Week to week paying students will not be charged for cancelled lessons if 24 hours notice is given, but the opportunity to reschedule the lesson may still be available if desired.

After the maximum of 2 cancellations per term has been reached, all further lessons will be charged at the standard rate, regardless of notice given.

Cancellation of lessons without the standard 24 hours notice being given are unable to be refunded or rescheduled.

For students paying week to week the outstanding fee is payable at your next lesson, or will be invoiced to you, payable within 14 days. For students who have paid up front, the lesson fee will be forfeited.

Lesson times are unable to be held for students after 3 or more consecutive missed lessons.

Please note that these terms and conditions of lessons are based on industry standards, and are essential to the fair practice of my business. If you have any questions or concerns about these conditions, please feel free to contact me.

I acknowledge that I have read the above terms and conditions, and I agree to give 24 hours notice for cancellation of a lesson, or forfeit the lesson fee; and that more than 2 cancellations per term will result in all further lessons being charged, regardless of attendance.
