



## Lesson Information:

Please note, when I'm teaching I will not answer phone calls, as the student in the room will be my focus. If your matter is not urgent please send me an email, or if you need to contact me about your lesson that day send me a text message instead as I will check these between lessons.

Lessons are held at 17 Browning Street, South Brisbane, in the *Ashville* building. When you arrive, walk to the end of the hallway and down the stairs, there is a small waiting area there near my studio (room 17).

To help you make the most out of your time, it is recommended to bring either an iPad/tablet/laptop or a folder where you can keep any lyrics, worksheets or sheet music we might use during your session. If you are working on original music in your lessons, lyric and/or chord charts are also appreciated.

**Voice rehabilitation/remediation sessions:** If you have seen a medical voice specialist, please consider bringing along any relevant reports and/or a copy of any videostroboscopy or laryngoscopy studies. You are also welcome to ask your ENT or Speech Pathologist to contact me prior to your lesson to discuss your case if you wish.

You will be invoiced at the beginning of each 10-12 week block. Please get in touch prior to each new term to request any date changes during the term.

## Terms and Conditions

The following are the Terms & Conditions of commencing lessons, including my cancellation policy.

After the initial/trial lesson, you will be bound by these conditions in order to hold your lesson time:

**When 24 hours notice is given, students are entitled to cancel 2 lessons per term.**

For students who have paid up front, a reschedule will be organised at a mutually convenient time, or this fee will be credited to your account for the following term. Week-to-week paying students will not be charged for cancelled lessons if 24 hours notice is given, but the opportunity to reschedule the lesson may still be available if desired.

After the maximum of 2 cancellations per term has been reached, all further lessons will be charged at the standard rate, regardless of notice given.

**Cancellation of lessons without the standard 24 hours notice being given are unable to be refunded or rescheduled.**

For students paying week-to-week, the outstanding fee is payable at your next lesson, or will be invoiced to you, payable within 14 days. For students who have paid up front, the lesson fee will be forfeited.

Lesson times are unable to be held for students after 3 or more consecutive missed lessons.
